Prof. Fangyuan Chen shared her research findings on consumer behavior at the Asia-Pacific Association for Consumer Research 2024 Conference.



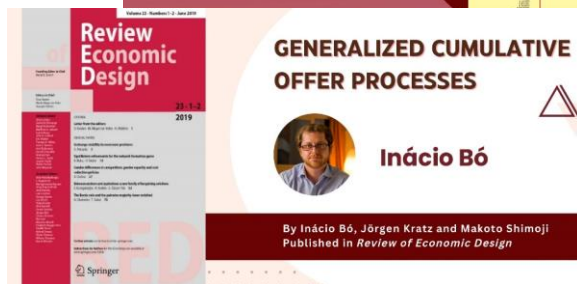
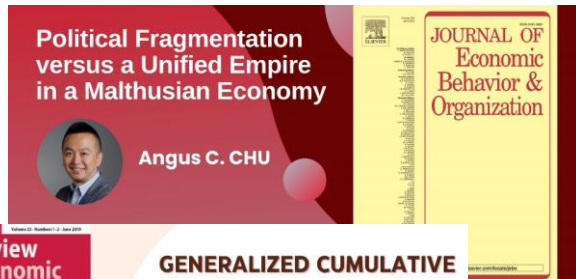
Prof. Xin Lin delivered a speech at the Mathematical Cognition and Learning Society 2024 Conference.

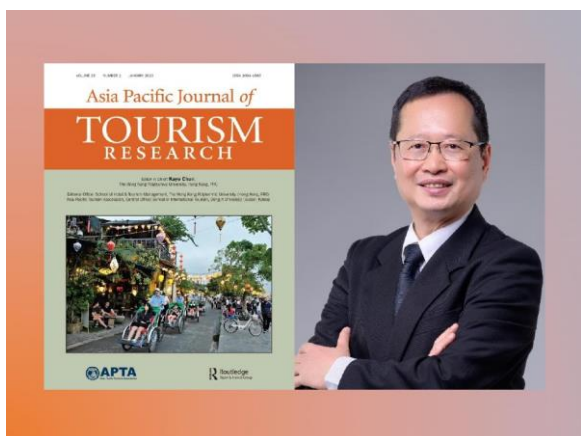
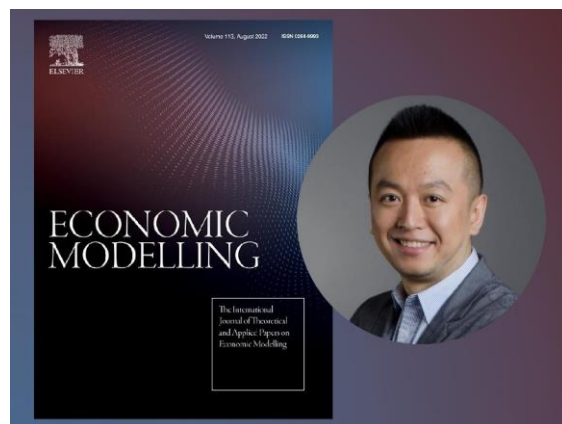
